
# Inter-agency cooperation in the quality assurance of transnational education: (INQAAHE funded study)


## The QACHE vicious circle







## The QACHE virtuous circle








## Higher Education Landscape in Dubai








## STUDENTS' ENROLLMENTS GROWTH





#### Mission

#### **CBQAN** shall take actions to:

- promote, encourage and share comparative studies in respect of quality assurance systems of cross-border higher education in Asia and Europe;
- formulate standards and guidelines for cross-border higher education quality assurance in Asia and Europe; encourage cross-border quality assurance activities based on the standards and guidelines; promote effective international cooperation on cross-border higher education;
- provide advisory information services on the cross-border education policy, quality assurance regulations, and cooperative programmes for the purpose of providing assistance to cross-border higher education institutions, experts and students in Asian and European countries;
- analyze the challenges in cross-border higher education quality assurance and propose possible solutions.

#### Origin

- ✓ The development of international higher education has brought cross-border education into the world focus.
- ✓ In order to promote international cooperation and raise awareness among countries of the importance of quality assurance for cross-border education
- ✓ Encourage the establishment of a comprehensive, fair and transparent system of registration or licensing for cross-border higher education providers wishing to operate in their territory
- ✓ Few international platforms are dedicated to facilitating cross-border education quality assurance.

**CBQAN Inaugural General** Assembly was held on 20th Dec. 2016, in Haikou, China, which marks the establishment of CBQAN.



#### Milestone - the CBQAN 2nd General Assembly


- On 19 Dec. 2018, the CBQAN 2nd General Assembly took place in Dublin, Ireland.
- Representatives from 11 higher education quality assurance or qualification recognition bodies of 8 countries (China, Estonia, Germany, Ireland, Latvia, Spain, UAE and UK) attended the meeting.
- > A range of results were yielded at the meeting:



- The First Council of CBQAN was constituted:
- The action plan for building Asia-Europe Higher **Education Excellent Quality Assurance** Programme Platform was agreed on in principle;
- The framework of Guidelines for Quality Provision in Cross-border Education by CBQAN was agreed on.

### International peer review

TNE QB review teams: composed of reviewers from both the sending location (region) and hosting location (region), allowing for hybrid review visits.

Peer review reports are reviewed by an international <u>TNE</u> <u>QB Advisory Board</u>: offering an extra layer of international peer scrutiny to inform the decision to confer the TNE QB Quality Mark, and strategic oversight of the scheme.

## The UNESCO Global Recognition Convention

...and develop the capacities necessary for ensuring reliability, consistency and complementarity in quality assurance, in qualifications frameworks and in the recognition of qualifications in order to support international mobility.
