

# **Quarterly Communiqué to the General Assembly**

# Quarter 1, 2019

This is Quarter 1 communiqué – January to March, 2019 – providing an update on the activities and achievements of INQAAHE. Overall, Q1 has been busy with the final arrangements related to the CEO's position, preparations for the INQAAHE 15<sup>th</sup> Biennial Conference in Sri Lanka, resolution of calls and preparations for the submission of the final manuscript of the INQAAHE Global Study to a publishing house.

## ORGANISATIONAL ASPECTS

- During Q1, arrangements were made to select the final candidate for the CEO position. Crystal Calarusse, the new INQAAHE CEO, was officially introduced to the network during this year's General Assembly Meeting in Sri Lanka. She will start her new position by end-April 2019.
- Due to the revisions in the membership categories and introduction of a new one INQAAHE GGP Aligned Member - the INQAAHE members qualifying for the new membership category were notified of the change in their status and the additional benefits.
- During this quarter, INQAAHE Global Study has been further developed by all its contributors so that its final manuscript can be sent to a publishing house by the end of June. The regional reports on each of the seven regions – Africa, Asia-Pacific, the Arab region, Eastern Europe, Latin America and the Caribbean, Northern America and Western Europe – are completed and will form the empirical part of the Global Study.
- During the Board meeting on the 28<sup>th</sup> of March, the Committees and Working groups were revised in line with the new Activity Plan 2019. See the table below for the new arrangements.
- The new Activity Plan was developed in Q1 and will be made public in April 2019.

#### SERVICES TO THE MEMBERS

#### INQAAHE FUNDING SCHEME

Results of the IFS Calls for the 2018-2019 round were announced during this quarter. An approved budget for 2018 of USD 30,000.00 has been allocated to fund the INQAAHE Funding Scheme (IFS) Window 2 (Capacity Building) and USD 5,000.00 for IFS Window 3 (Research and Innovation) (see the approved IFS Operational Manual 2017).

Overall, 18 capacity building and 4 research proposals have been received. As the call states, 3 capacity building proposals and 2 research proposals were awarded.



#### QAP PROGRAMME

INQAAHE is offering a Quality Assurance Programme through two HEIs – University of Melbourne (language of instruction is English) and Open University of Catalonia (language of instruction is Spanish). Calls for the 2019 round were announced and granted during this quarter.

Overall, 10 applications were received. As the <u>call</u> states, 4 scholarships of up to USD 5,000.00 each were granted in total: 2 to the Graduate Certificate in Tertiary Education (Quality Assurance) at the University of Melbourne, and 2 to the Master's degree on Quality Management and Evaluation in Higher Education at the Open University of Catalonia (UOC).

#### FUNDING FOR ATTENDING INQAAHE CONFERENCE 2019

Just like each year, INQAAHE has a limited budget allocated to assist its members from least developed countries to attend INQAAHE Conferences and Forums (up to USD 2,500.00 per application). The call was both announced and awarded during this quarter. 46 applications were received; 5 of them were funded to attend the Conference, members from Zimbabwe, Bangladesh, Pakistan, Bhutan and Vietnam.

#### INQAAHE CONFERENCE 2021 BID

A proposal to host INQAAHE Conference 2021, submitted by QAA UK, was received by the set deadline. The proposal was presented at the General Assembly meeting in Sri Lanka. The revised version will be circulated among the GA and an e-voting on the proposal will decide the venue for the INQAAHE 2021 Conference.

#### BOARD STRATEGIC INITIATIVE

A proposal developed by Dr Leah Matthews, Vice President of INQAAHE, was approved by the Board under window 1 of INQAAHE Funding Scheme (strategic initiatives). The project aims to establish a certified QA professional training program, a need that has been long identified.

#### **EVENTS**

#### THE INQAAHE XV BIENNIAL CONFERENCE 2019

The 15<sup>th</sup> INQAAHE Biennial Conference 2019 was hosted by the University Grants Commission (UGC), Sri Lanka. The conference theme was: *Quality Assurance, Qualifications, and Recognition: Fostering Trust in a Globalised World.* The conference was held in Colombo, Sri Lanka, from the 25<sup>th</sup> to 28<sup>th</sup> of March, 2019 at the Bandaranayake Memorial International Conference Hall (BMICH). Overall, both the pre-conference workshops and the Conference itself were a complete success: around 89 people were present during the workshops and nearly 300 delegates from 47 different countries attended the event.



35 papers and 9 posters were presented during the Conference. Previous INQAAHE Funding Scheme projects had also a chance to present their outcome and/or progress of their proposals during the event.

Voting of 2018 annual report and accounts will be done electronically since the minimum quorum to do so during the General Assembly Meeting was not reached in Sri Lanka.
