I hope this message finds you well. I am writing to provide a comprehensive explanation of RAO University's situation, our commitment to educational excellence, and the critical need for your support in our application for Associate membership with INQAAHE.

RAO University, established in 2022, is an online educational institution based in Afghanistan, specifically created to counter the Taliban's decision to close universities to women and deny them access to higher education. Our mission is to offer free, high-quality education to Afghan women, empowering them to contribute meaningfully to their communities despite the severe restrictions imposed by the current political regime.

Since its founding, RAO University has been dedicated to providing educational opportunities that align with global standards, even though our operations are constrained by significant political and social challenges. The Taliban's extremist policies have led to systematic discrimination against women's education, presenting severe obstacles to our efforts. Despite these adversities, we remain resolute in our mission, driven by a commitment to human rights and gender equality.

Our attempts to register and gain formal recognition within Afghanistan have been met with resistance from the Taliban. On January 9, 2024, one of our senior members, who was actively working on our registration process, was detained by Taliban intelligence. This individual endured severe torture and is now permanently disabled as a result of the brutal treatment. This unfortunate incident highlights the grave risks faced by our staff and the extreme challenges we encounter.

The Taliban's sanctions and hostile environment have severely hindered our ability to obtain necessary licenses or formal registration. Despite these setbacks, RAO University continues to operate as a non-governmental, non-profit institution, providing education to thousands of Afghan women through a robust online platform. However, to enhance the quality and credibility of our programs and to ensure that our students receive internationally recognized qualifications, we need to achieve formal accreditation and recognition.

We firmly believe that Associate membership with INQAAHE would significantly benefit RAO University in several ways:

- 1. International Accreditation and Recognition: Gaining Associate membership would support our efforts to obtain global accreditation for our programs. This recognition is crucial for ensuring that our students' qualifications are valued internationally, allowing them to pursue further education or career opportunities with confidence.
- 2. Quality Assurance Framework: Membership with INQAAHE would provide us with access to a network of quality assurance experts and resources. This support would be invaluable in helping us develop and implement a rigorous quality assurance framework that aligns with international standards and best practices.
